INFORMATION FOR POLICE OFFICER APPLICANTS

All applicants must provide an individual photograph, not in a group, taken within the last two years. All applicants must also provide a photocopy of their current driver's license. These submissions are required for background investigation purposes.

All applicants must sign the statement at the bottom of this sheet to authorize a thorough background investigation prior to employment. Please indicate if you do not wish your current employer contacted.

All finalists for a full time Police Officer position will be required to submit to a finger print check for background information purposes.

All finalists for a full time or part time Police Officer position will be required to provide Alert Test verification from the Maine Criminal Justice Academy.

All finalists for a full time or part time Police Officer position will be required to have received Maine Criminal Justice Academy Certification (1 00 hour course minimum).

All finalists for a full time Police Officer position may be required to take a post-offer psychological examination.

The finalist for a full time or part time Police Officer position will be required to pass a post-offer physical examination (as required by the Maine Criminal Justice Academy).
